EXECUTIVE COMMITTEE REPORT 2017/2018

Dear Friends and Members,

- Our all-volunteer community service group is able to continue our service all these 42 years because of your strong support and generous contribution. A BIG THANK YOU from the aged and needy whom you are helping to make their lives more meaningful.
- We had a Volunteer Gathering over High Tea on 11 Nov 2017. This was an opportunity for us to share ideas and show our appreciation to all volunteers who contribute so much of their time and efforts.

COMMUNITY SERVICE

FAMILY ADOPTION SCHEME:

About 200 aged and needy families continue to receive monthly financial assistance from us. Our volunteers visit many of these families on a monthly basis and, where required, provide them with some emotional support. Many of these cases are referred to us by the medical social workers from the various hospitals and also by the social workers from the various Family Service Centres and other VWOs.

CARE & SHARE PROJECT:

In celebration of Singapore 50th Anniversary in 2015, the Government launched a new project "Care and Share" and matched donations raised by us during a 16-month period from 1 Dec 2014 to 31 Mar 2016 at a ratio of 1.25 to 1. This new Care and Share Project fund can only be used for any new prescribed projects (not existing ones) that we may have from 2015 to 31 Mar 2019. Drawing from this grant, we started giving Festive Bonus to our adopted families during Chinese New Year, Hari Raya Puasa, Deepavali and Christmas, as well as for educational need, emergency funding and asset replacement.

MEALS SCHEME:

About 100 eldery continue to be served with meals once weekly at Toa Payoh East and thrice weekly at Telok Ayer Hong Lim Green. This is a joint project with the community centres' volunteers.

MEAL DELIVERY SCHEME:

We co-support the new "Healthy Hot Happy Meal" project of Henderson Dawson Citizens' Consultative Committee, whose volunteers themselves prepare and deliver nourishing soup and food every Sunday to 40 lower-income "socially isolated" old folks living in the Henderson-Bukit Merah View area. Due to their physical or mental disabilities, these elderlies are unable to venture beyond their flats and thus meals delivered to their doorsteps would really make their day.

- 3. Our executive committee member, Ms Ng Su Ran, raised \$16,000 from sale of items donated by a client of her company.
- 4. <u>Cargill Group</u> continues to have some of its staff to volunteer in our group. <u>Cargill International Trading Pte Ltd</u> donated \$13,000.
- 5. <u>The Halliburton Giving Choices, USA</u> made a 10% top-up to the donations from their staff and remitted a total of \$2,318.38 to us.
- 6. <u>Clifford Chance Pte Ltd</u> continues to have some of its staff to volunteer in our group and its staff gave Christmas gifts to children of 20 adopted families in our group and also vouchers to these 20 families.
- 7. Scandinavian Women's Association continues to look after 3 of our adopted families.
- Advanced Holdings Ltd have some of its staff to look after 3 of our adopted families.

NOTE

- The GOVERNMENT GRANT FOR CARE & SHARE PROJECT CANNOT BE USED FOR EXISTING PROJECTS. The grant can only be used for capability and capacity building and new social service projects. We tap on this grant for projects like Festive Bonus (given to our adopted families during Chinese New Year, Hari Raya Puasa, Deepavali and Christmas), educational need, emergency funding and asset replacement.
- WE STILL DEPEND ON YOUR DONATIONS FOR OUR FAMILY ADOPTION SCHEME, which needs the most funding. This can be seen from the above Summary that funding of our Family Adoption Scheme was from the Unrestricted General Fund Account, which had only a very small surplus of \$6,526 # for Year 2017.
- 3. Most of the larger surplus of the Consolidated Accounts for Year 2017 is for the RESTRICTED Care & Share Fund Account (meant for special projects only).

APPENDIX 1

STATEMENT on POLICY relating to MANAGEMENT, AVOIDANCE OF CONFLICT OF INTEREST AND RESERVES

- Our Executive Committee (EXCO) ensures that stakeholders' interests are protected and accountability is being practiced. The constitution and minutes of meetings are the written documents of operation.
 - As an Institution of a Public Character (IPC), we will abide with the IPC requirements.
 - The EXCO itself manages and conducts the affairs of the Group as we are an all-volunteer charity without any staff. Only members can be elected or co-opted into our EXCO. Our EXCO must meet at least once every 3 months. (During the term under review, our EXCO met bi-monthly). Urgent matters are discussed/decided via telephone &/or e-mail and ratified at the next EXCO meeting.
 No EXCO member shall receive any profit, salary or emolument from our Group or from any
 - No EXCO member shall receive any profit, salary or emolument from our Group or from any transaction. (Since formation, none has received any of the said).
 - Our EXCO is supported by the Family Advisory Committee (FAC) to ensure that there is professional expertise in the vetting of applications for aid and to facilitate decisionmaking. Our FAC comprises experienced members and/or social workers who volunteer their services.
- EXCO members are to declare conflicts of interest to the EXCO and are not to participate in nor
 vote on such matters. (We have no such material transactions for or required for supplies,
 services, premises, etc. There is also no related party transaction nor commercial third-party
 arrangement).
- 3. To keep a maximum of 3 years' estimated expenses as reserves.
